Investment objective and policy

These discretionary managed model portfolios offer risk-profiled investment solutions, all of which have a dynamic top-down asset allocation strategy implemented using low cost index tracking funds.

The investment objective for the Dynamic Passive 4 Model Portfolio is to provide a long-term total return which is superior to inflation plus 3% returns. The performance of the model portfolio is not intended to track the rise (or fall) of any specific index.

November was an extraordinary month. Joe Biden became the US President-elect and there are now several vaccine candidates going through trials which demonstrate good promise. Market sentiment was so upbeat on hopes of a vaccine-driven economic recovery that the S&P 500 and the MSCI world equity index hit new record highs.

Hopes of an economic rebound also resulted in a surge in oil prices during November, which helped the FTSE 100 post a record monthly gain, rising 12.4%. Mining shares, which have a high weighting in the index, rallied as China continued its recovery from the infection.

The positive mood across markets hurt demand for safe-haven assets, with gold posting its largest monthly decline in four years and the dollar seeing a period of weakness, which many expect to continue. There was also a rotation out of the sectors that have performed well during the crisis. The rapid pace of progress towards an effective vaccine lifted shares in companies that had been hardest hit by measures to control the spread of the infection, such as travel and leisure.

Investors are facing a mismatch ahead: a bad economic environment over the next few months, with ongoing pressure on the corporate sector, but the prospects of a much brighter outlook once we reach the spring. A strong upturn in activity will still require considerable policy support. With fiscal policy likely to be less supportive next year (unless the Democrats take the US Senate), there will be ongoing pressure on central banks to ease monetary policy further.

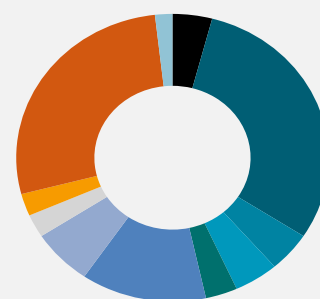
In November, UK equities were amongst the top performing asset classes for the model, with the vaccine news being the catalyst for the largest monthly gain in the FTSE 100 since January 1989. Elsewhere, the rotation driven by the 'reopening narrative' led to some profit taking in big technology and health care, whilst banks, oil majors and retail were brought into favour after a difficult year. This positive trend extended to property shares, despite the continuing uncertainties about tenant demand and rental levels for retail and office investments. Although only a small position, L&G Global Robotics & Automation Index fund was one of the best performing holdings on hopes of faster economic growth next year.

No changes were made to the model in November.

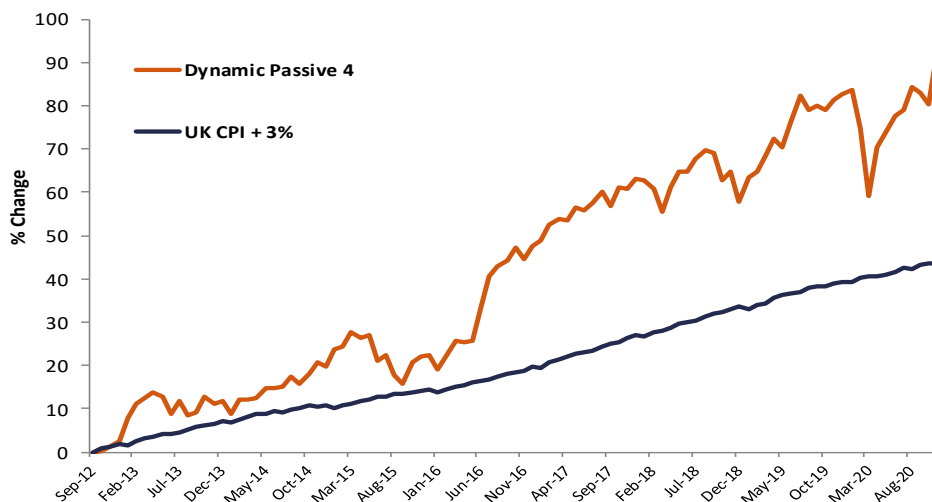
Investment Team
